**CONDITIONS FOR MEMBERSHIP**

1. Membership is open only to persons over the age of 18. For ages under 18, evidence of parental or supervisory consent is required.
2. Membership is valid for one year only and is not transferable.
3. Membership fee is N500.00 (five hundred naira) for individuals, N5, 000 (five thousand Naira) for Non Governmental Organisations and N10, 000 (ten thousand Naira) for corporate and international organizations.
4. 2 passport photographs of contact person, and an official application letter should accompany all application forms.
5. Organisations are to submit 3 names of staff authorised to collect films.
6. Videocassettes will be rented only to authorised staff on presentation of the company membership card.
7. Video cassettes may be hired or returned during our opening hours from Monday to Friday (10.00 am – 4.00 p.m.)
8. Films can be rented at N50 per day. Weekend rate is N100 from Friday to Monday. After 3 days, the fee is increased to N100 per day. Films must be returned after 5 days maximum.
9. Members are allowed to borrow only 2 tapes at a time.
10. In case of loss of a videocassette, payment for replacement will be demanded.
11. Do not expose rented tapes to extreme heat, cold, direct sunlight, dust and dirty machine heads.
12. Membership will be cancelled with immediate effect in the event of violation of rules or damage to or theft of audio-visual materials.
13. Any infringement of copyright regulations (e.g. copying or broadcasting) will result in immediate disqualification from membership of the Centre.
